## 1 Introduction

## 1.1 **Purpose of the Guide**

- 1.1.1 This document is the Guide to the Application (the Guide) for the Wylfa Newydd Project. It provides a guide to the documents prepared in support of Horizon's Development Consent Order (DCO) application which was submitted to the Planning Inspectorate in June 2018. The Guide follows a similar format to that of Richborough Connection Project, which is set out as an exemplar document by the Planning Inspectorate.
- 1.1.2 The Guide to the Application includes Table 2-4. Table 2-4 is the Examination Document Tracker. It will be a live table which Horizon will update throughout the DCO Examination, assisting with document referencing during examination and clearly establishing the status of each application document. This will be achieved by differentiating between current and superseded versions of documents.
- 1.1.3 The table presents information for each of the documents submitted with the DCO application. This includes the Planning Inspectorate's Examination Library reference numbers and Horizon's Document reference numbers. Table 2-4 includes the folder and Volume in which documents can be found. The table identifies which documents are certified and refers to the relevant regulation for each document.

## 1.2 The Wylfa Newydd Project

1.2.1 Horizon is proposing to construct and operate the Wylfa Newydd Project, which comprises the Wylfa Newydd DCO Project, the Licensable Marine Activities and the Enabling Works. Each of these elements is described further below. The Wylfa Newydd DCO Project will be consented under a DCO, the Enabling Works will be consented through planning permissions, and the Licensable Marine Activities will be consented under a Marine Licence. There is some overlap between the two; the Marine Works (see below) will be consented under both the DCO and the Marine Licence.

#### Wylfa Newydd DCO Project

1.2.2 The Wylfa Newydd DCO Project comprises those parts of the Wylfa Newydd Project which are to be consented by a DCO, namely:

#### The Nationally Significant Infrastructure Project (NSIP)

- Power Station: the proposed new nuclear power station at Wylfa, including two UK Advanced Boiling Water Reactors, the Cooling Water System, supporting facilities, buildings, plant and structures, radioactive waste and spent fuel storage buildings and the Grid Connection;
- other on-site development: including landscape works and planting, drainage, surface water management systems, public access works

including temporary and permanent closures and diversions of public rights of way, new Power Station Access Road and internal site roads, car parking, construction works and activities including construction compounds and temporary parking areas, laydown areas, working areas and temporary works and structures, temporary construction viewing area, diversion of utilities, perimeter and construction fencing, and electricity connections;

- Marine Works comprising:
  - Permanent Marine Works: the Cooling Water System, the Marine Off-loading Facility, breakwater structures, shore protection works, surface water drainage outfalls, waste water effluent outfall (and associated drainage of surface water and waste water effluent to the sea), fish recovery and return system, fish deterrent system, navigation aids and Dredging;
  - Temporary Marine Works: temporary cofferdams, a temporary access ramp, temporary navigation aids, temporary outfalls and a temporary barge berth;
  - Off-site Power Station Facilities: comprising the Alternative Emergency Control Centre (AECC), Environmental Survey Laboratory (ESL) and a Mobile Emergency Equipment Garage (MEEG);

#### Associated Development

- the Site Campus within the Wylfa Newydd Development Area;
- temporary Park and Ride facility at Dalar Hir for construction workers (Park and Ride);
- temporary Logistics Centre at Parc Cybi (Logistics Centre);
- the A5025 Off-line Highway Improvements;
- Wetland habitat creation and enhancement works as compensation for any potential impacts on the Tre'r Gof Site of Special Scientific Interest (SSSI) at the following sites:
  - Tŷ Du;
  - Cors Gwawr;
  - Cae Canol-dydd
- 1.2.3 The following terms are used when describing the geographical areas related to the Wylfa Newydd DCO Project and the Licensable Marine Activities:
  - Power Station Site the indicative areas of land and sea within which the majority of the permanent Power Station, Marine Works and other on-site development would be situated; and

 Wylfa Newydd Development Area – the indicative areas of land and sea including the Power Station Site and the surrounding areas that would be used for the construction and operation of the Power Station, the Marine Works, the Site Campus and other on-site development (WNDA Development).

#### **Licensable Marine Activities**

1.2.4 The Licensable Marine Activities comprise the Marine Works and the disposal of material from Dredging at the Disposal Site.

#### **Enabling Works**

- 1.2.5 The Enabling Works comprise the Site Preparation and Clearance Proposals (SPC Proposals) and the A5025 On-line Highway Improvements.
- 1.2.6 Horizon has submitted applications for planning permission for the Enabling Works under the Town and Country Planning Act 1990 to the Isle of Anglesey County Council (IACC).
- 1.2.7 In order to maintain flexibility in the consenting process for the Wylfa Newydd DCO Project, the SPC Proposals have also been included in the DCO application. The A5025 On-line Highway Improvements are not part of the DCO application.

## 2 Application Documents

### 2.1 Policy and legislative requirements

- 2.1.1 Regulation 5(2) of The Infrastructure Planning (Applications: Prescribed Forms and Procedures) Regulations 2009 (amended) ('APFP Regulations') sets out the prescribed documents that must accompany a DCO application. Regulation 6 of the APFP Regulations also identifies prescribed documents that must accompany applications for specific types of projects.
- 2.1.2 Table 2-4 lists each of the documents submitted to support the DCO application in accordance with Regulation 5(2) and 6 of the APFP Regulations. The policy or legislative requirement relevant to each of the documents is also provided.
- 2.1.3 The Wylfa Newydd DCO Project comprises the construction of a generating station, related highways infrastructure, harbour facilities and hazardous waste facilities. Horizon has also prepared the documents prescribed in Regulations 6(1), 6(2), 6(3) and 6(5).
- 2.1.4 The Project is an Environmental Impact Assessment ('EIA') development. The Infrastructure Planning: (Environmental Impact Assessment) Regulations 2017 replaced The Infrastructure Planning (Environmental Impact Assessment) Regulations 2009 on 16 May 2017. The submitted Environmental Statement has been undertaken in accordance with the 2009 EIA Regulations as the Scoping Report was submitted prior to May 2017. However, where possible, the Environmental Statement takes account of the amended provisions of the 2017 EIA Regulations.
- 2.1.5 The submitted application complies with the statutory requirements of the Planning Act 2008, the APFP Regulations and the EIA Regulations 2009. The application has also been prepared in accordance with guidance from the Secretary of State and the Planning Inspectorate, particularly Advice Note 6 'Preparation and submission of application documents' (February, 2016).

## 2.2 Welsh Language

- 2.2.1 Planning Inspectorate's Advice Note Six 'strongly urges applicants to provide appropriate application documents in English and Welsh'.
- 2.2.2 Horizon and the Planning Inspectorate have agreed that Horizon will provide Welsh language versions of non-technical documents and summaries of certain technical documents. This approach aligns with the approach taken in previous DCO applications in Wales and Horizon's own Welsh language policy. Table 2-1 details the application documents which will be translated into Welsh.

- 2.2.3 During the DCO Examination Horizon will fully comply with the Planning Inspectorate's Welsh Language Scheme (2014). In accordance with the Scheme, members of the public will be able to speak in Welsh at Examinations. Horizon will provide simultaneous translation facilities at the Preliminary meeting and all Examination hearings.
- 2.2.4 The Planning Inspectorate will welcome written representations in Welsh but will respond to all representations in English only. This approach is necessary given the statutory requirement under section 98 of the Planning Act 2008 for the Examining Authority to complete its Examination within a six-month period. This is in line with the approach taken during the recent Examination of the Glyn Rhonwy Pumped Storage DCO application.

### 2.3 DCO application structure

- 2.3.1 The application documents are separated into eight Volumes, which correspond to The Planning Inspectorate's recommended categories as set out in Appendix 1 of Advice Note Six '*Preparation and submission of application documents*'. The contents of each Volume are summarised below.
- 2.3.2 Summaries of documents are embedded at the start of each document, unless otherwise indicated in the Examination Document Tracker in Table 2-5.

#### Volume 1. Application Form

2.3.3 Volume 1 contains the DCO Application Form and supporting documents which include the Application Cover Letter, this Guide to the Application, Notices of Statutory Publicity and the Development Consent Order Glossary.

#### Volume 2. Plans, Sections and Drawings

- 2.3.4 This Volume contains all of the:
  - Order Limit Plans These plans set out the Order Limits for the authorised development. The Order Limits define the area within which the authorised development may be constructed, operated and maintained;
  - Land Plans These plans identify limits of the land to be acquired and used ("the LLAU") and the individual plots over which Horizon intends to exercise its compulsory acquisition powers;
  - Work Plans These plans identify the Order Limits for the authorised development identified in Schedule 1 as well as the limits of deviation for each of the Works;
  - Parameter Plans These plans identify the zones within which buildings, structures and works identified in the parameter tables in the Requirements must be located;
  - Rights of Way These plans identify the existing public and private rights of way that will be stopped up or diverted and any new rights of ways to be provided, either during construction or operation; and
  - Detailed Plans These are the detailed design plans that Horizon is seeking approval for specific works.
- 2.3.5 The Land Plans for each site include a unique plot number for each plot of land. The plot number ranges are shown in Table 2-2.

2.3.6 In addition, this Volume contains plans showing Crown Land and Special Category Land. All approved plans are included as part of Schedule 2 of the Wylfa Newydd (Nuclear Generating Station) DCO (the draft Order).

- 2.3.7 The Environmental Statement Volume D includes a series of figures which illustrate the statutory and non-statutory sites or features of nature conservation (Application Reference Number 6.4.9) and the historic environment (Application Reference Number 6.4.11). The figures are accompanied by an assessment of effects likely to be caused by the Wylfa Newydd DCO Project.
- 2.3.8 Floor plans for buildings at the Power Station Site are not included in the detailed drawings where appropriate in the interest of the operational security of the Power Station.
- 2.3.9 Following Planning Inspectorate advice received on 22 June 2017, a number of plans are provided at a scale smaller than 1:2500 where necessary to assist the understanding of the Wylfa Newydd DCO Project, including to illustrate works across the Wylfa Newydd Development Area on a single plan.
- 2.3.10 The following categories are used to indicate the level of detail shown on the plans:
  - 'For approval': the detail included on the plan is submitted for approval. The construction of the Wylfa Newydd Project would be carried out in accordance with the details shown on the plan unless otherwise approved. These plans will be secured either through the articles or the requirements in Schedule 3 of the draft Order.
  - 'Illustrative': the detail shown on the plan is provided for illustrative purposes only. The plan illustrates one way in which the development or an element of it might be arranged in accordance with design principles developed for the site, but it is not a commitment to implement the development as illustrated. The final layout of the development, or the relevant part thereof, would be submitted to the relevant planning authority for approval under the Requirements in Schedule 3 of the DCO. These details may differ from the illustrative layout in the DCO application. Where details are to be submitted for approval under the Requirements they must be in accordance with the Works Plans and Parameter Plans, and the design principles for that site (as set out in the relevant volume of the Design and Access Statement).
  - 'For information': these plans show existing details (e.g. the existing site features and layout). They are not for approval as part of the application but are provided to inform consideration of the application and to provide necessary context.
- 2.3.11 The preparation of plans has been produced in accordance with the relevant regulations of the APFP Regulations and Advice Note Six.

#### Volume 3. Draft Development Consent Order

- 2.3.12 This Volume contains the draft Order and presents the legal powers and rights being applied for in order to construct, operate and maintain the Wylfa Newydd DCO Project.
- 2.3.13 The draft Order contains, under Schedule 1, the individual work packages which comprise the construction of the Wylfa Newydd Project (both Nationally Significant Infrastructure Project and other associated development works). Schedule 3 of the draft Order sets out the requirements that apply in the construction and operation of the Wylfa Newydd Project.
- 2.3.14 The draft Order is accompanied by a mark-up of the draft Order against the Infrastructure Planning (Model Provisions) (England and Wales) Order 2009 (Model Provisions) which identifies the variations between the articles in the draft Order and the Model Provisions. While the Model Provisions have been repealed, Advice Note 13: *Preparing the draft order and explanatory memorandum* identifies that it is still useful for the Planning Inspectorate to receive a track-change to show departures from the Model Provisions.
- 2.3.15 The Explanatory Memorandum which describes the purpose and effect of each provision (as required under the APFP Regulations) in the draft Order is also located in Volume 3. Where the Order departs from the Model Provisions, an explanation of the new provision is provided and any relevant precedents identified.

#### **Volume 4. Compulsory Purchase Information**

2.3.16 Volume 4 contains the information relevant to the application for powers of compulsory purchase. The Statement of Reasons clarifies why compulsory acquisition is required and justified, while the Funding Statement sets out how this will be funded. A Book of Reference is included in Volume 4 and identifies those Persons with Interest in Land and land which Horizon may seek to exercise its powers of compulsory purchase over.

#### Volume 5. Reports

- 2.3.17 This Volume includes the Consultation Report, the Habitats Regulations Assessment, Environmental Protection Act Statement and the Overarching Flood Consequences Assessment Signposting Document.
- 2.3.18 Volume 5 also contains the details of other consents and licences not forming part of the draft Order and which Horizon will be applying for separately.

#### **Volume 6. Environmental Statement**

2.3.19 Volume 6 contains all the Environmental Statement chapters and appendices. The Environmental Statement is separated into Volumes ranging from A to J. Volumes A and B provide introductions to the Wylfa Newydd Project, the approach to the Environmental Impact Assessment, and the topic specific assessments. Volume C presents the assessment of the project-wide effects, while Volumes D to H consider the site-specific effects. Within each sitespecific Volume are the topic-specific assessments of effects for the site. The cumulative effects of the Wylfa Newydd Project are assessed in Volume I. Volume J contains the environmental commitments and summarises the residual effects.

2.3.20 Detailed technical assessments, surveys and reports that underpin the assessment findings of the Environmental Impact Assessment are included as appendices to appropriate Volumes of the Environmental Statement.

#### **Volume 7. Regulation 6 Statements**

2.3.21 Volume 7 contains the Grid Connection Statement as required for projects comprising generation stations by Regulation 6(1) of the APFP Regulations. Although the Project does not meet the NSIP criteria under the Planning Act 2008 relating to harbour facilities and hazardous waste, Horizon has also provided additional information for the Planning Inspectorate in respect of these facilities which form part of the Project. The purpose of this is to provide the Planning Inspectorate additional narrative as to why these project components are needed.

#### **Volume 8. Other Documents**

- 2.3.22 This Volume contains each of the remaining reports which accompany the application for a DCO. The Planning Statement establishes the planning policy context against which the Wylfa Newydd DCO Project is reviewed. The Design and Access Statement is formed of three Volumes. The first is project-wide, the second focuses on the Power Station and Off-site Power Station Facilities, while the third Volume focuses on the Associated Development.
- 2.3.23 A series of assessments, key control documents under the Requirements (such as Codes of Practice and Strategies) and other strategies are also presented in this Volume. The full list is set out below:

Jobs and Skills Strategy	Sets out the strategy for employing and training staff and encouraging local employment.



## 2.4 Securing Mechanisms in the DCO

- 2.4.1 This section outlines how the mitigation identified in the Environmental Statement and other assessments will be secured and provided.
- 2.4.2 As noted above, Schedule 3 of the draft Order sets out all the requirements that Horizon must comply with in undertaking the construction, operation and maintenance of the Wylfa Newydd Project. The Requirements in Schedule 3 of the draft Order are structured as follows:
  - Project-wide requirements: These are overarching requirements that apply to all works packages, such as time limits for commencement and overall phasing of the Wylfa Newydd DCO Project;
  - Works-specific requirements: These are requirements that apply to a specific works package(s) within the Project (e.g. requirements relating only to Parc Cybi). Work-specific requirements relate to compliance with:
    - the relevant sub-CoCP and Management Strategies;
    - parameters (where applicable);
    - phasing of construction;
    - requirement to submit Management Schemes and design details for approval; and
    - operational requirements.





2.4.3 As shown on the figure 2-1 above, the Requirements provide that Horizon will comply with a number of control documents in carrying out the Wylfa Newydd Project. These documents, as described in Table 2-4, establish the framework for the construction, operation and maintenance of the Wylfa Newydd DCO Project, and will be certified by the Secretary of State.

<b>Document Title</b>	Document Description
The Wylfa Newydd Code of Construction Practice (CoCP) and sub-CoCPs	The Wylfa Newydd CoCP, together with location-specific sub-CoCPs, sets out how construction activities will be managed and controlled in order to deliver the mitigation commitments set out in the Environmental Statement as well as other assessment processes undertaken (e.g. Habitat Regulations Assessment). Sub-CoCPs are provided for the Main Site, Marine Works, Off-Site Power Station Facilities, the Logistics Centre, the Park and Ride Facility and the A5025 Off-line Highway Improvements. These sub-CoCPs set out specific controls relevant to those locations which are not adequately covered under the Wylfa Newydd CoCP.
The Wylfa Newydd Code of Operational Practice (CoOP)	Similar to the CoCPs, the Wylfa Newydd CoOP sets out the controls that will apply during the operation of the Project (e.g. operating hours). The CoOP will be a certified document and Horizon will be required to comply with it under the Requirements.
Design and Access Statement (DAS)	The DAS sets out the "design principles" that will guide how Horizon will construct the authorised development, and illustrative design concepts which demonstrate how the Wylfa Newydd DCO Project could be brought forward in accordance with those principles. The Requirements require detailed building design to be submitted and approved in accordance with the design principles in the relevant volume of the DAS. Any revised plans will also need to be in accordance with the principles in the DAS.
Workforce Management Strategy (WMS)	The WMS sets out the principles which Horizon and its partners will follow to manage and control the behaviours of contractors and the workforce. Horizon will be required to develop a Code of Conduct

	with its partners in accordance with the principles set out in the WMS for the management of workforce conduct, as well as specific protocols of those residing at the Site Campus. Workers will then be required to comply with the resulting Code of Conduct through their labour agreements.
Landscape and Habitat Management Strategy (LHMS)	The LHMS sets out how key landscape elements and habitats within the Wylfa Newydd Development Area will be created and managed in order to mitigate the adverse ecological effects identified in the Environmental Statement. It will include the illustrative reference point drawings as an appendix.
Construction Method Statement (CMS)	The CMS sets out the construction methodologies, works, and machinery required for works on the Power Station Main Site. The methodologies identified in the CMS have been used for the basis of the EIA assessment. The construction of the Power Station Main Site will be undertaken in general accordance with the CMS and Horizon will be able to change the methodologies used from those identified in the CMS provided there are no materially new or different effects from those assessed in the Environmental Statement.
Phasing Strategy	This Phasing Strategy establishes the overall sequence of construction of the Wylfa Newydd DCO Project. As the Wylfa Newydd DCO Project comprises construction works across multiple sites, the purpose of this Strategy is to describe the relationship between each of those sites and demonstrate when key mitigation, needed to offset the effects from the construction of the Wylfa Newydd DCO Project, will be provided. The Requirements provide that the construction of the Wylfa Newydd DCO Project will be undertaken in accordance with the phasing outlined in the Phasing Plans



### Welcome

Horizon Nuclear Power is proposing to build and operate Wylfa Newydd, a new nuclear power station on Anglesey, generating enough low carbon electricity to power around five and a half million homes.

Large projects like Wylfa Newydd are known as Nationally Significant Infrastructure Projects (NSIPs). They require a Development Consent Order (DCO) application that is determined by UK Government. Horizon has applied for a DCO from the UK Secretary of State for Business, Energy and Industrial Strategy.

The DCO process is managed by The Planning Inspectorate (rather than the local council as for traditional planning applications), and provides opportunities for stakeholders to comment on the application.

This booklet is a guide to navigating your way through our DCO application for Wylfa Newydd. It sets out the structure of the documents so you can find the information you are interested in.
